

19.3 Summary of access and usage permissions available to You and Your Patrons

• Non-Linear Lending (The lending model that applies to most of our titles) 19.3.1

An Ebook supplied with NLL acc	cess permissions can be used by You under the following terms:	
Typically 325 Loan Instances	Patrons may borrow the Ebook for an equivalent total of 325 Loan instances per year. The Ebook may be lent to more than one Patron at a time but the total combined number of loan instances used cannot exceed 325 per year. Where usage reaches 325 instances, You will be denied the ability to lend that Ebook until the end of that year, at which point You will be entitled to another 325 instances for the new year. At any time, You may purchase another copy of the same Ebook and will be entitled to an additional 325 Loan instances per year.	
HTML Preview	Patrons may review metadata, summary and table of contents of an Ebook on-line for an unlimited period.	
Free online browsing	Ebook may be viewed on-line by an unlimited number of Patrons for a maximum of 10 minutes once every 24 hours for each Patron. In cases where You have catalogued titles that your library has not yet bought from EBL, Your patrons may view those Ebooks for 5 minutes.	
On-line Loans	Any on-line viewing that exceeds the browse period by the same Patron will be deemed to be an on-line Loan ("Loan Instance").	
Off-line Loans	A Patron may download an Ebook to their computer for nominated Loan periods. Once downloaded, the Ebook may be transferred by the Patron to two authenticated devices within the allotted Loan period. Unless the Patron has logged in and renewed the Loan, the Ebook will be disabled on their machine(s) once the Loan period has expired.	
Reserve collection	Where permitted by the publisher, You will be entitled to place, as a separate holding in Your Reserve Collection, either an entire Ebook or one Chapter of any Ebook.

*Last year in the UK more than 400 bookshops closed down, seven times more than in 2011.

*There are now less than 2,000 bookshops left in the UK, less than half the number of seven years ago.















E-BOOK TITLES PURCHASED: GROWTH

SOME REMARKS FROM SURVEYS

- "Difficult to get access, something always goes wrong & you end up spending more time trying to find the book than just getting the hard copy"
- "I use only journal articles"
- "Don't like reading in a computer screen more than I already do"
- "It was difficult to obtain relevant text, but perhaps it was due to the fact that the whole system was new to me"
- "Sometimes they load very slowly, or are in use by other people"
- "Sometimes the pages take very long to load and you can only see one page at a time"
- The book could only be downloaded in 40 page batches. This took me forever"
- "I find them cumbersome to access and thus I would prefer to use hardcopy books"
- "I think e-books are excellent because you have a copy of the book that you can keep and you can print as and when needed.
- "I recommend e-books to all my students however, the problems mentioned above are frustrating and students then return to requesting hard copies from library"
- "E-books are great"
- "I am sure I will use it in future and also make prescribed books available for students"

PDA

Purchases are *triggered* only when *meaningful use in EBSCOhost* occurs:

- >10 minutes active use in full text
- > 10 page views in full text
- Downloading eBook
- Printing, copying, saving, emailing full text

Budget Implications

Choosing the right Platform, the right PDA Model

How fast will your money be depleted

Can you change the content of the PDA while it is in operation

Workflow implications

What is acceptable as a trigger purchase? 5 minutes? 10 minutes?

Balanced collection? Or does it really matter?

The DARK side to PDA
